# Spring Meeting Virginia State University April 17–18

The Spring meeting of the MD-DC-VA section of the MAA will be held at Virginia State University.

Virginia State University (VSU) was founded on March 6, 1882, when the legislature passed a bill to charter the Virginia Normal and Collegiate Institute. The bill was sponsored by Delegate Alfred W. Harris, a black attorney with offices in Petersburg who lived in and represented Dinwiddie County in the General Assembly.

A hostile lawsuit delayed opening day for nineteen months until October 1, 1883. In 1902, the legislature revised the charter act to curtail the collegiate program and to change the name to Virginia Normal and Industrial Institute.

The two-year branch in Norfolk was added to the college in 1944; the Norfolk division became a four-year branch in 1956 and gained independence as Norfolk State College in 1969. Finally, the legislature passed a law in 1979 to provide the present name, Virginia State University.

VSU is situated in Chesterfield County at Ettrick, on a bluff across the Appomatox River from the city of Petersburg. It is accessible via Interstate Highways 95 and 85, which meet in Petersburg. VSU is only two and a half hours away from Washington, DC to the north, the Raleigh-Durham-Chapel Hill area to the southwest, and Charlottesville to the northwest.

# GOVERNOR'S REPORT

I was happy to see that so many people from our section were able to attend the Joint Mathematics Meeting in Baltimore. I wish that I'd been able to be in multiple places at once to hear more sessions. (That would be feathers in my caps, eh?) It does well for our profession that there were so many talks.

- (1) First, the MAA Board of Governers meeting. Probably the most noteworty item was that the mortgage on the Headquarters building in DC has been paid off: the Association now owns the building, the (ersatz) mortgage was burned at the Board meeting. (Actually it was that flaming paper that magicians use, and I'm told that our own Brent Morris was involved in setting up some of the pops.)
- (1a) Marcia Sward (Executive Director of the MAA) reported that there are now more than 1500 Departmental Liaisons registered with the MAA. Please check that your department has one. If it doesn't, find/appoint one.
- (1b) The issue of our corporate deficit was also discussed. It is my understanding that the books are not closed yet on 1997, but we anticipate a deficit of about \$154k. Although this is not something to ignore, the 1998 projection is still for a balanced budget. Realistic projected increases in publication sales, advertising, and contributions should allow us to maintain this posture for the year. Donations ARE still accepted, however! Frankly, these are difficult times for many associations, not just the MAA; and I believe that we must take a hard corporate look at where we want the MAA to be in ten years. Who will our constituency be? What will their needs be? What is the demographic future of the Association?
- (1c) Once again, the MAA is sponsoring the Toronto Mathfest this coming July 15-18 in Toronto, Ontario, Canada. Please make every effort to support it by your attendance. The program looks very diverse, and very interesting. (I would make exactly the same comment were I not chairing the Program Committee. Honest!)
- (2) One of the talks I did catch was by MAA President-elect Tom Banchoff on visual mathematics over the Web. His Web sites is accessible via MAA Online ("Communications in Visual Mathematics"), and I'd encourage you to look there for some interesting "matherial." The talk almost went belly-up at start when the Internet connection failed, but some interpid legwork (e-work, maybe?) by on-site technicians saved the day.
- (3) Another point about MAA Online: there's now a link from there to "amazon.com" for book purchases. So what, you say? Well, the MAA gets a small amount from Amazon for every book purchased that was chased down via MAA Online. So if you need a book, try finding it via MAAOnline → amazon.com and make a small donation to the good guys.
- (4) I also crashed the meeting of the FOCUS / MAA Online Advisory Group. There are many changes afoot for the format and content of both of these publications. As many of you have seen, FOCUS has already changed, and is moving to a more timely publication. MAA Online has been recognized to make the front page shorter (and therefore presumably easier to digest). Our "corporate electronic front door" has already won an award for being a superlative web site. This award is based on content, not glitz. Stay tuned for more.

I look forward to seeing many of you at Virginia State, and in Toronto.

# **Elections at Spring Meeting**

We will hold elections for two Section offices at the Spring meeting:

The Chair Elect serves for one year in that position and then becomes the Section Chair in the following spring. # MINUTES OF THE BUSINESS MEETING

Saturday November 22, 1997

The meeting was called to order by Chair Betty Mayfield. She thanked local arrangements coordinator Theresa Francis and her colleagues for arranging the meeting and the members of the Executive Committee for planning and assisting at the meeting.

Minutes and Treasurer's Report: The minutes of the spring 1997 meeting were approved followed by the Treasurer's report from Jon Scott. Scott reported that the section was doing well financially. He reported a balance of \$6673.51 in the general fund and \$1053.50 in the Milcetich Fund. He also reported that the attendance at the meeting was 146, including 37 students.

Future Meeting: The dates of future meetings were given. They are: (a) Spring of 1998 April 17-18 at Virginia State University in Petersburg, Virginia; (b) Fall of 1998 November 13-14 at Towson State University, Maryland; and (c) Spring of 1999 (tenatively April 9-10) at James Madison University in Harrisonburg, Virginia.

Elections: Kevin Colligan's term as Governor expires this year; so a new Governor of the section is to be elected. Elections take place by mail. The nominees this year are Helen Christensen of Loyola College in Baltimore, Dick Morris of Virginia Commonwealth University in Richmond, and Jon Scott of Montgomery College in Takoma Park. In the spring the Section Chair and the Program Chair will be elected. The Executive Committee will serve as the nominating committee with Betty Mayfield to act as the collector for the nominees. Attendees were invited to send in nominations for these two offices to any member of the executive committee.

Awards and Prizes: Nominations for the John Smith Award for Distinguished College or University Teaching are being collected by George Mackiw of Loyola. Members were urged to nominate their peers for this award. The John Milcetich Prizes for Student Presentations are given at the spring meeting each year. This year the section will offer two different types of prizes - one for expository talks and one for research talks. The evaluation form is being revised. It will be sent to students and faculty in advance so that they will know how they will be evaluated.

Competitions: The High School Examination will be given February 10 with the Junior High Examination being given November 20. Our section has always had a very active group of participants and a dedicated group of faculty who work to organize these competitions. MAA members were encouraged to support these competitions in secondary schools in their communities; colleges may wish to "adopt" a school and raise money for students' participation. Betty Mayfield and Kevin Colligan have information about the examinations for anyone interested.

Students Conference: Tentatively scheduled is a student conference for the 1999 spring meeting at James Madison. Kathleen Shannon and Andy Vogt, our student chapters coordinators, are working on a plan.

**Department Liaisons:** The department liaisons will meet at the spring conference at Virginia State. Eve Torrence, Section Liaison Coordinator, will organize this meeting.

Tribute: A tribute to Professor Ted Benac of the United States Naval Academy, an active member of the Section for many years, who passed away this year was given.

Announcements: Kathleen Shannon announced an undergraduate research conference to be held at Salisbury State University the weekend of April 25. Genevieve Knight solicited the names of young women who will be attending the national meetings in Baltimore so that they could be invited to participate in several Association for Women in Mathematics (AWM) events.

Other: The secretary was asked to write a letter of appreciation to Mount Saint Mary's College for hosting the meeting.

Arriving by U.S.460 from Suffolk (east) or Roanoke (west): Take I-95 North to Petersburg exit 50D (Washington Street). Turn left on Washington Street and continue to Sycamore Street. Turn right at Sycamore Street and continue to end of street (Old Street). Turn left at Old Street (changes to Grove Avenue) and continue on Grove to Fleet Street. 

# Spring Meeting: Virginia State University MEETING HIGHLIGHTS

On Friday evening, our featured speaker will be **Dr. Edward Burger**. Known for his unusual and entertaining presentations, Dr. Burger will present a talk "Innovative Experiments in Mathematics and Beyond...and how I survived them". He has given numerous research and pedagogical lectures, including two AMS invited lectures at the 1996 AMS-MAA summer meetings and an invited address at the 1997 MAA summer meeting. He is an MAA Visiting Lecturer and has just completed a text "The Heart of Mathematics: An Invitation to Effective Thinking" to be published by Springer-Verlag.

Saturday will consist of almost 36 contributed papers, the business meeting, and book displays. Some of the Putnam and Comap winners will present their results. The best of the student paper presentations from the morning will be recognized at an award ceremony prior to the keynote Invited Lecture.

The Saturday Keynote Lecture will be given by **Dr. Ronald Graham**, Polya Lecturer for the MAA and Chief Scientist for AT&T Labs. Dr. Graham is world renowned for his numerous contributions to combinatorics, graph theory, discrete and computational geometry, thoeretical computer science, and applications thereof. His accomplishments include numerous publications, invited presentations at international conferences throughout the world, editorial positions with the most prestigious journals and various honors and distinguished professorships. His talk is entitled "Juggling Permutations of the Integers".

#### Change in Section By-Laws Proposed

The Executive Committee is proposing a change in the term of office of the Program Chair. At present, the Program Chair serves a two-year term and is prevented from succeeding himself or herself. Those who have held this position indicate that it is difficult to jump right in and begin this job, and then, just as you get the hang of it, it's over! We have discussed several solutions and suggest the following change:

In odd-numbered years, we will elect a Vice Program Chair. He or she will serve one year in that position, in a sort of apprenticeship, learning about the job and helping the Program Chair. In the following spring, he or she will become the Program Chair and serve a two-year term.

This spring we will elect a Program Chair for a regular two-year term. If our Section membership approves the suggested change in by-laws, we will send it to the Board of Governors. If they approve, then we can elect our first Vice Program Chair in the Spring of 1999.

The relevant portion of Article III, section 4 of the By-Laws of our Section now reads:

Election of officers for the Section shall take place annually at the spring meeting. The Chair shall be elected in each even numbered year to a two year term which shall start after the following spring meeting. During the year following her or his election and before taking office he or she shall be the Chair Elect and in the year following her or his term of office he or she shall be the Immediate Past Chair. The position of Chair Elect may be held concurrently with another elected office. \*The Program chair shall be elected in even numbered years for a two year term.\* The Program Chair ... may not succeed herself or himself if he or she has served a full term.

The Executive Committee proposes replacing the sentence between the asterisks with the following statement:

The Program Chair shall be elected in odd numbered years for a two year term which shall start after the following spring meeting. During the year following his or her election and before taking office he or she shall serve as Vice Program Chair.
